1. DEFENSIVE DRIVING COURSE

You may be able to require that one charge be dismissed by completing a driving safety course. Written notice of your intent to do so must be delivered to the Court on or before your appearance date. **DO NOT TAKE THE COURSE WITHOUT COURT APPROVAL.**

2. If you FAIL TO RESPOND to the charge(s) by the appearance date shown on the citation, an additional charge of violate promise to appear will be filed and warrants issued for your arrest. Failure to appear in court as required by law might lead to the denial of license renewal and additional fees or costs.

3. A JUVENILE who fails to appear by the time and date on a citation may have their license suspended as required by law. JUVENILES 16 and under must contact Court with parent or guardian before appearance date on citation.
