- Call to order, invocation, pledge
   Judge Therwhanger called the meeting to order with a prayer and pledges of allegiance.
- 2. Public Forum: Open the floor for public forum. (Public comments and presentations will be limited to a maximum of three (3) minutes, unless a member of the court requests additional time for the presenter.)

Adam Niolet, City Manager, stated he was out of state at the last agenda which he was to speak and apologized for not being in attendance.

- 3. Discuss routine administrative items: take action needed;

Commissioner Rosson made a motion to approve the routine administrative items as presented. Commissioner Elder seconded the motion. Motion carried unanimously. (see attached)

4. Meet with the County Attorney, a representative of the Public Health Department, Ms. Olivia Flores and Ms. Aidee Villa concerning a public health complaint and follow up inspection at their residence identified as BLK G SEC 127 WTRR CO TOWN & COUNTRY ESTATES W/2 W/2TR 82 to determine why the owners of the location have not been able to clean up the excess trash and garbage stored in plastic bags stacked behind the mobile home in a timely manner; take action as appropriate

Zack Holbrooks, Health Department, stated there have been numerous communication efforts to Aidee Villa regarding cleaning up the area in the back of her house with no response. Aidee Villa stated she had not had the funds to purchase a dumpster previously and at this time was employed and would request time to buy one and have it placed at her residence. Commissioner Rosson made a motion to allow Mrs. Villa until February 18<sup>th</sup> to have the trash cleaned up at her residence. Commissioner Elder seconded the motion. Motion carried unanimously.

5. Meet with interim Chamber of Commerce Director Shawntay Pettyjohn to receive a report on recent events and to discuss July 4<sup>th</sup> plans; take action as appropriate

Shawntay Pettyjohn, Interim Chamber of Commerce Director, stated how much herself and the chamber board appreciated the support from commissioners court. She updated the court on various activities the chamber would be doing within the year. She requested \$20,000.00 for the pyro-tech show, use of the park building facility, porta potties, no golf carts within the park, provide dumpsters & roll offs and no personal grills on the facility outside entry for the Freedom Fest to be held July 1, 2023. Commissioner Houston made a motion to approve the

\$20,000.00 for the pyro-tech show, use of park building facility, provide porta potties, no golf carts within the park, provide dumpsters & roll offs and to place a sign stating no personal grills in the park facility entry way. Commissioner Murphree seconded the motion. Motion carried unanimously. (see attached)

6. Consider approval of a contract with Industrial Scientific for  $H_2S$  monitors; take action as appropriate

Robert Barrett, Emergency Management Director, stated we currently have 8 monitors and he recommends continuing using the current company as they if there is ever an error on any monitor they instantly get a report and will replace at no charge. Commissioner Rosson made a motion to approve the renewal contract with Industrial Scientific. Commissioner Houston seconded the motion. Motion carried unanimously. (see attached)

Consider approval of a quote to repair courthouse panic buttons using courthouse security funds; take action as appropriate

Scott Shortes, IT Director, stated all panic buttons within county facilities are out of date and he recommended using JL3 Integrated Solutions. He stated once the button is pressed it goes to the security personal within the courthouse and dispatch. Commissioner Elder made a motion to approve JL3 Integrated Solutions for updating the courthouse panic buttons, in the amount of \$1,567.20. Commissioner Houston seconded the motion. Motion carried unanimously. (see attached)

8. Consider approval of a "No Pet Policy" in courthouse, except for ADA approved service animals; take action as appropriate

Commissioner Murphree made a motion to approve a No Pet Policy in the courthouse, except for ADA approved service animals. Commissioner Elder seconded the motion. Motion carried unanimously.

Consider approval of installing LED lighting for the Seminole Senior Citizen Building; take action as appropriate

Commissioner Houston made a motion to approve the installation of cost effect LED lighting for the Seminole Senior Citizens Building in the amount of \$3,767.40. Commissioner Rosson seconded the motion. Motion carried unanimously.

10. Open bids for Precinct 4 Truck; take action as appropriate

Commissioner Murphree made a motion to approve the one Bid received for Precinct 4 from Bruckner Truck Sales, Inc. for a 2023 Mack Truck in the amount of \$79,490.00 with 3 trade-ins as follows: 1999 Mack Dump Truck-Unit #4087, 1992 Chev. Dump Truck-Unit #4048 & 2007 International Truck Unit #4147. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)

11. Consider approval of change in scope estimated cost of EOC building project; take action as appropriate

Judge Therwhanger stated there was a discrepancy in the cost of the EOC building project, stating the approved amount was \$551,200.00 however the cost in the newspaper stated \$748,456.00. Wayne Gondeck, DRG Architect, per phone call, explained to commissioners court the increase cost was the need for a new generator. He stated January 24, 2023 he would be here with the construction people to explain the EOC building construction. Commissioner Murphree made a motion to approve the increase cost needed for the EOC building construction as stated above. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)

Commissioner Houston made a motion to approve the designation of County Judge Cindy Therwhanger to serve on the Board of Directors of the Permian Basin Regional Planning Commission for her entire term as Gaines County Judge. Commissioner Murphree seconded the motion. Motion carried unanimously.

15. Consider approval of having ADA accessible door (10) open for public access from 8-5 on regular business days; take action as appropriate

Commissioner Elder made a motion to approve having ADA accessible door (10) open for public access from 8-5 on regular business days. Commissioner Houston seconded the motion. Motion carried unanimously.

16. Discuss ARPA funds; take action as appropriate

Following much discussion Commissioner Murphree stated the need for the funds to be used for infrastructure such as EOC building project and other county buildings before any funds are allotted to each department per attached "wish" list. Commissioner Houston made a motion to use the ARPA funds for the EOC building project and further research to be done for infrastructure repairs and needs. Commissioner Rosson seconded the motion. Motion carried unanimously. (see attached)

 Consider approval of subdivision application(s), take note of known subdivision exceptions, consider any requests for subdivision variances; take action as appropriate;

Commissioner Elder stated he has received several calls from the public stating the need to file subdivision and he is unclear as to respond. Commissioner Murphree stated the lawyers are not actually complying with the commissioners concerns of making the Subdivision Policy a simple process for clear understanding. Judge Therwhanger stated she would contact the parties involved and get clarification and have them come to the next commissioners court to address any concerns.

Esmeralda Felan, Auditor, stated Davis, Ray & Company will be present at the next Commisioners Court meeting to give a report on the outside audit.

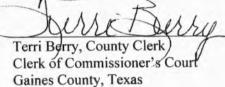
