Call to Order - Judge Cindy Therwhanger Invocation
Pledge - United States and Texas

- 1. Introducing a new Juvenile Probation Officer.
  - The new employee, Chrystal Richardson was not in attendance.

  - Judge Therwhanger presented Elected Officials proposed increase in pay with 2.5% raise and longevity. No public comment

  - Judge Therwhanger stated this budget will raise less revenue from property taxes than last year by an amount of \$487,854.76 which is a 2.0138% decrease from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$773,678.78. No action taken (see attached)
- 6. To consider, discuss and take any necessary action on the proposed tax rates to fund the Tax Year 2025/Fiscal Year 2026 General and Flood Control/Lateral Road Maintenance and Operation budgets; take action as appropriate.
  - Judge Therwhanger presented the prosed tax rate at \$0.0523555 per \$100 (General .316795 and Flood Control//Lateral Road .161760) No action taken (see attached)
- 7. Consider adopting the proposed Calendar Year 2025/Fiscal Year 2026 budget; take action as appropriate.
